



New Auto Loans Disclosure

A New Vehicle is defined as follows:

- You will be the registered owner
- The vehicle has never been titled
- Vehicle must be current or prior model year
- Less than 7,500 miles
- Maximum loan amount up to 115% of Manufacturer's Suggested Retail Price (MSRP), including tags, title, tax and extended warranties
- Minimum loan amount for 36, 48 and 60 months is \$5,000
- Minimum loan amount for 72 months is \$15,000
- Minimum loan amount for 84 months is \$25,000
- Apple FCU does not finance commercial, salvage, lemon law, delivery, true mileage unknown, water/flood/frame damage, branded title, grey market vehicles, 1+ ton, limousines or taxis.
